TERMS AND CONDITIONS

Loyalty Program Terms and Conditions

Loyalty Program (herein “Program”) is offered by HF Markets (SV) Ltd (herein “the Company” or “HFM”) to its Clients under the following Terms and Conditions.

1. Introduction

- 1.1. The Program is available to all Clients of the Company who have satisfied the Criteria as set out in this Program’s Terms and Conditions.
- 1.2. This Program is available to Company’s Clients that:
 - a) have opened an Account with the Company as per the Account Opening Agreement;
 - b) have completed the age of 18 or the legal age applied in his country of residence or must not be otherwise considered as a ‘minor’ in his country of residence;
 - c) have accepted the Terms and Conditions of this Program;

2. Availability and Promotion Period

- 2.1. The Program period runs from 12th of January 2026 onwards.

3. Terms and Conditions

- 3.1. This Program applies to Existing and New Clients.
- 3.2. Qualifying Clients of this program earn points known as *Trophy Road Points* (herein “TRP”).
- 3.3. Upon the joining of client in the Loyalty Program, all subsequent trading activity from the client's Accounts shall automatically be counted towards the Program's requirements.
- 3.4. TRP cannot be earned from activity and/ or volume generated on PAMM Master and Investor accounts; Demo accounts.
- 3.5. TRP cannot be transferred between Accounts.
- 3.6. TRP cannot be earned on qualifying activities conducted before the date of joining this program.
- 3.7. The Client may, at any time, request to opt out of the Program and request a reset of the Program by submitting a request via email. Approval of any reset is subject solely to the Company's absolute discretion.

- 3.8. If the Client records zero (0) Loyalty Activity for two (2) consecutive Evaluation Periods, the Client's current Loyalty Rank will be downgraded to the appropriate lower level.
- 3.9. In the event that an account remains inactive for a period of 365 consecutive days, the available TRP balance shall be reset to zero. The lifetime balance shall remain unaffected.

Trophy Road

- 3.10. Client rank within the Program is determined by two criteria: Trading Volume and Active Trading Days. To achieve and maintain a rank, a client must meet specific targets for both criteria during each Evaluation Period. The targets are displayed in the Rewards Center area.
- 3.11. Each client is subject to a 30-calendar-day Evaluation Period. The initial Evaluation Period begins on the client's Loyalty Program joining date. Any subsequent upgrade to a new rank shall reset the Evaluation Period, commencing a new 30-day countdown from the date of the rank update.
- 3.12. Only the round-turn closed trades that are opened after the client's Loyalty Program joining date and have a minimum of 2 minutes duration shall be counted towards the Trading Volume.
- 3.13. Only trading volume made with funds deposited by the Client is counted. If a trade is made with both cash and bonus, then only the cash portion is counting onwards the Loyalty Trading Volume.
- 3.14. The trading volume is the Funded Notional Volume in USD.
- Loyalty Volume in USD
- $$= (\text{Lot Size} \times \text{Contract Size} \times \text{Market Price} \times \text{Conversion USD Rate (at opening)}) + (\text{Lot Size} \times \text{Contract Size} \times \text{Market Price} \times \text{Conversion USD Rate (at closure)})$$
- 3.15. An "Active Trading Day" is defined as any calendar day (from midnight to midnight server time) on which a client has at least one eligible trade that is either open, closed, or carried over from the previous day. Pending orders shall not be counted as trading activity.
- 3.16. Based on your trading the rewarding TRP are cumulative added to your loyalty balance, TRP earned = Loyalty Trading Volume * Trading Group TRP * Account Type Ratio * Booster Ratio. The Pro Plus Account has an Account Type Ratio of 0.4, and the Infinity X Account has an Account Type Ratio of 0.5.

- 3.17. The system will round down on the 2nd decimal of the TRP earned. This is also applied when the amount of earned TRP is 0.004 then the amount of TRP received will be 0 and will appear so in the TRP history.

Loyalty Missions

- 3.18. The Clients shall be eligible to receive TRP based on the completed levels of the Missions.
- 3.19. Each mission can have multiple levels with specific Requirements.
- 3.20. Each level has specific Requirements that need to be met within a set timeframe.
- 3.21. In case a mission does not have any levels, then specific Requirements apply to that mission.
- 3.22. The Requirements that apply to each mission or level are displayed in the description of each mission or level in the Rewards Center area.

- 3.23. All levels of a mission are active at the same time but the Client will not be able to progress to the next level (even if its time period has ended) until all Requirements of the current level have been fully met.
- 3.24. Completion of each level will automatically unlock the next level.
- 3.25. Clients shall be eligible to receive their TRP upon completing the Requirements of a mission or a level of a mission.

4. Rewards

- 4.1. Based on the Trading Activity and Missions, TRP are earned, which are added to the Client's Total Trophy Road Points.
- 4.2. Based on their cumulative TRP, the user is entitled to claim the appropriate Prizes.
- 4.3. Each Trophy Road prize can be claimed only once.
- 4.4. In order to claim a gift, the Client must have sufficient available TRP in their account. Upon claiming a gift, the equivalent TRP value of the gift will be deducted from the Client's available TRP balance.
- 4.5. Clients are eligible to convert/exchange their available TRP for cash reward(s). The equivalent cash amount will be credited directly to the Client's Account, based on the conversion rates and terms displayed in the Rewards Center area. Upon conversion, the corresponding TRP value will be deducted from the Client's available TRP balance.
- 4.6. In case the company is unable to provide the selected Reward, we reserve the right to replace it with the equivalent Cash Reward.

5. Conditional Access to Premium Services

- 5.1. The Company may, from time to time and at its sole discretion, introduce and offer various tier-based subscription packages, third-party tools, or premium features (herein "Services") via the Rewards Center or Loyalty Program.
- 5.2. Access to certain Services may be offered free of charge (0 TRP cost) to Clients who achieve and maintain specific high-level loyalty ranks.

- 5.3. The Company reserves the absolute right to unilaterally modify, suspend, or terminate a Client's free access to any such Service at any time, without prior notice or the Client's consent.
- 5.4. In the event that a Client's loyalty rank is downgraded to a lower level that does not qualify for the respective free tier offer, any active complimentary subscription or access shall be automatically terminated, and access to the Service will be revoked immediately.

6. Acknowledgements

- 6.1. The Client hereby acknowledges, confirms and accepts to be legally bound by the Terms and Conditions as set out in this Promotion and/or any other legally binding Agreement between him and the Company.
- 6.2. By registering and participating in the Promotion, the Client confirms that he has read, understood and agreed to be bound by the Terms and Conditions of the Promotion and any other Terms and Conditions of the Company that may apply.
- 6.3. The Client by participating in the promotion, authorizes the Company to announce interim results and their names on the Company's websites on a regular basis.
- 6.4. By claiming and accepting a prize, each winner agrees for their image and name to be used for marketing and promotional purposes on the Company's website (to be specified and carried out at the sole discretion of the Company).
- 6.5. The Client acknowledges and confirms that they shall accept responsibility for any taxes that may be incurred as a result of accepting a prize.
- 6.6. The Client acknowledges that trading CFDs is highly speculative and involves a substantial risk of loss of the invested capital or more than the invested capital. The Client acknowledges that where the Company has any indication or suspicion of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage connected to a Trading Account or any other forms of deceitful or fraudulent activity, then the Company reserves the right at its sole discretion to:
- a) Close/ suspend all Trading Accounts the Client has with the Company either temporarily or permanently;
 - b) Void all previously credited trading bonuses from the Client’s Trading Accounts with the Company;
 - c) Void all transactions carried out, including any pending orders and/or any profits or losses earned.
- 6.9. The Client acknowledges and understands that where any of the circumstances mentioned in Clause above, occur, the Company will not be liable for any consequences on the Bonus cancellation, including, but not limited to, order(s) closure by Stop Out.
- 6.10. These Terms and Conditions are made in English language. Any other language translation is provided as a convenience only. In the case of any inconsistency or discrepancy between original English texts and their translation into any other language, as the case may be, original versions of English shall prevail.

7. Dispute

- 7.1. Any dispute arising with or in connection to any of the Terms and Conditions of this Rewards shall be dealt by the Company as per the Company’s Complaints Handling Policy, which is available on the Company’s website.
- 7.2. All complaints must be in writing and addressed to the Customer Support Department of the Company via email at support@hfm.com. More details on the procedure which the Client must follow, the deadlines for receiving a response from the Company as well as contact details for the Company’s regulatory authority can be found on the Company’s website in Section “Legal Documentation”.

8. Amendments

- 8.1. The Company reserves the right, at its absolute discretion, to unilaterally modify, change or terminate the Promotion or any of the Terms and Conditions included herein, at any time without the Client's consent.

9. Termination

- 9.1. The Company reserves the right to refuse offering the Promotion to any Client of the Company at its sole discretion without the need to provide any justification.
- 9.2. If the Company suspects and/or has any reason to believe that a Client has submitted fraudulent details and/or false identification information during the Account Opening Process and/or during the registration for the Promotion, the Company reserves the right at its absolute discretion to disqualify the Client from this Promotion and/or any other contest or bonus program or promotion offered by the Company.
- 9.3. If the Company suspects or has reasons to believe that any Client has abused and/or manipulated and/or breached in any way any of the Terms and Conditions of this Promotion and/or any other promotion and/or contest and/or bonus program offered by the Company and/or has not acted in good faith, the Company reserves the right at its absolute discretion to (i) void and/or withhold and/or withdraw any winning prize and/or any payment of the Prizes reached by the Client and/or (ii) completely disqualify the Client from this Promotion and/or any other promotion and/or contest and/or bonus Program offered by the Company with immediate effect.
- 9.4. If the Company suspects or has any reason to believe that a Client has abused and/or manipulated any of the Terms and Conditions of this Promotion and/or any other contest or bonus program or promotion offered by the Company, by hedging his positions internally (using other trading accounts held with Company) or externally (using other trading accounts held with other brokers) and/or has not acted in good faith, the Company reserves the right, at its absolute discretion and without obtaining the Client's consent, to remove the Promotion from the Client's Trading Account(s) or from his winning hedged Accounts and/or withdraw and/or withhold any winning prize from the Client with immediate effect.

The provision of the loyalty program shall not be considered as advice and/or recommendation to deposit and/or trade any trading instrument offered by the Company.
